

Service Mode Interpretation by CUSTOMS:

Service Mode	Considered as
CY-CY	FCL
CFS-CY	FCL
CY-CFS	LCL
CFS-CFS	LCL

FCL/Part: When there more than one consignment loaded in a single box and all the consignments are consigned to <u>same consignee</u>, manifest can be submitted as CY-CY (aka FCL) but since the container is available under more than one BL, manifest must be submitted as **'PRT'** for the container under all the BLs'. This mode is known as **FCL/PART**.

Service Mode Acceptability:

Exception: If Consignee is a Freight Forwarder (with AIN Number), following is acceptable:

Important Notes:

1. Following BL & Container Combination is unacceptable as one BL contains 2 containers (1 LCL & 1 FCL). It is not allowed to declare two service different service modes for two different containers.

Unacceptable:

BL: MCDXXXXXX; Consignee: A Company; Container: MRKUXXXXXX, MSKUXXXXXX (2 Containers)

BL: MCDYYYYYY; Consignee: B Company; Container: MRKUXXXXXXX (1 Container only)

Should Be:

BL: MCDXXXXXX; Consignee: A Company; Container: MSKUXXXXXX, Service Mode: CY-CY BL: MCDXXXXXX; Consignee: A Company; Container: MRKUXXXXXXX, Service Mode: CY-CFS BL: MCDYYYYYY; Consignee: B Company; Container: MRKUXXXXXXXX, Service Mode: CY-CFS

2. While any manifest amendment is requested by consignee for inclusion of Split BL, no matter if the consignee is the same or not, Service Mode of all related BLs' must be CY-CFS. This is a clear guideline by Customs and they won't accept any amendment request with service mode CY-CY

Additional Guideline:

- a) For Personal Effects Cargo, no BIN needs to be mentioned.
- b) BIN is also known as VAT registration Number. BIN can be verified from www.nbr.gov.bd.
- c) Customs prescribe format is to input the BIN on Consignee and Notify Column for specific party.
- d) If any shipper provides either of 9 Digit, 11 Digit and 13 Digit BIN in Specific Party Column, Customs and NBR has clearly instructed to input 13 Digit BIN in manifest.

AIN vs BIN:

• AIN [Agent Identification Number] is applicable for Freight Forwarders

On the other hand,

 BIN [Business Identification Number] also known as VAT Registration Number is applicable for Banks and Importers.

NON-License Freight Forwarder:

For Freight Forwarders, Agent Identification Number (AIN) is mandatory. If any AIN number is invalid, that specific customer will be reckoned as 'Non-Licensed Freight Forwarder'. If any such cases found, containers cannot be discharged at BDCGPTM and it must be **retained on board.**
