For 20' containers with gross weight exceeding 30 MT, THC charged will be double the normal rate.
<b>F.2</b>	<b>Rail Freight Facilitation Charge:</b> INR 1000/- per Container (If STT will pay rail Freight).
<b>F.3</b>	The THC for hazardous cargo shall be double the normal rate.
